GENERAL OVERVIEW

Introduction

Cross Creek Christian School is an interdenominational 501 (c)(3) nonprofit organization recognized by the State of Tennessee as a Category IV Church Related School. Cross Creek is a member of the Association of Christian Schools International.

Cross Creek Christian School is pleased to offer instruction, support, and opportunities to families who have chosen to educate their children at home. Parents can decide between our University-Style class program, which includes classroom instruction and lesson plans, or our total home education program that allows the parent to choose the curriculum and provide all the instruction at home. Both programs include record keeping, annual testing opportunities, field trips, school photos and yearbook, graduation ceremonies, and extra-curricular activities.

Cross Creek Christian School offers:

- Parent directed education in a Christian environment
- PreK-12th grades: you select the classes that fit your academic plan
- A partnership between the family and our qualified teachers
- A high school diploma for those successfully completing the graduation requirements
- Affordable education: you pay only for the classes you take
- Standardized testing is optional
- Personal attention in a small class setting
- School field trips and activities
- A total home education program with record keeping service
- More time to be with your child(ren), making a positive impact in their lives and enhancing a stronger family relationship

Philosophy of Education

We work in partnership with parents to help their student reach his or her fullest potential. We are dedicated to helping families who have chosen this challenging but rewarding path.

At Cross Creek, parents are considered the primary teacher who is working cooperatively with our classroom instructors in providing a quality, Christ-centered education for their child(ren). As such, parents are considered to be classroom instructors with their home functioning as a satellite campus of Cross Creek Christian School, Inc.

We believe in the academic freedom of our parents. Just as the State cannot regulate our churches, it does not regulate us as a church-related school. We believe that it is your right and responsibility to educate your child(ren) in the way that you determine is academically and spiritually appropriate.

Spiritual Foundation

Cross Creek is an interdenominational Christian school. As such, we do not teach or promote any specific denominational doctrine. It is our goal to be of service to the entire Body of Christ. Teachers are encouraged to pray for and with their students and their families and the needs that they may present. We encourage our staff to be sensitive to the Holy Spirit and obedient to His direction throughout the day, stopping to pray or to discuss God's Word in relation to the materials being taught. We invite you to include us in your prayers. Please pray daily for Cross Creek's Board of Directors, administration, faculty, staff and students.

Though Cross Creek families represent a number of denominations, we require that each staff member and family entering the school agree to support the basic doctrines summarized in the statement of faith below. All spiritual and academic instructions and issues of conduct and relationships are approached from this Christian worldview. Individual families and churches should address specific denominational issues beyond these tenants.

Statement of Faith

Cross Creek Christian School's policies and operations are based upon the following Statement of Faith:

1. **We believe** the Bible to be the inspired, the only infallible, authoritative, inerrant Word of God (II Timothy 3:16; II Peter 1:21).
2. **We believe** there is one God, eternally existent in three persons – Father, Son, and Holy Spirit (Genesis 1:26; Matthew 28:19; John 10:30).
3. **We believe** in the deity of Christ (John 10:33):
 - His virgin birth (Isaiah 7:14; Matthew 1:23; Luke 1:34)
 - His sinless life (Hebrews 4:15; Hebrews 7:26; 2 Corinthians 5:21)
 - His miracles (John 2:11)
 - His vicarious and atoning death (1 Cor. 15:3; Ephesians 1:7; Hebrews 2:9)
 - His resurrection (John 11:25; 1 Corinthians 15:4)
 - His ascension to the right hand of the Father (Acts 1:9-11; Colossians 3:1)
 - His personal return in power and glory (Acts 1:11; Revelation 19:11)
4. **We believe** in the absolute necessity of regeneration by the Holy Spirit for salvation because of the exceeding sinfulness of human nature; and that men are justified on the single ground of faith in the shed blood of Christ and that only by God's grace and through faith alone are we saved and kept by the power of God unto eternal salvation (John 3:3, 16-19; John 5:24; Romans 3:23; Romans 3:28; Romans 5:1, 8-9; Ephesians 2:8-10; Titus 3:5).
5. **We believe** in the resurrection of both the saved and the lost; they that are saved unto the resurrection of life, and they that are lost unto the resurrection of damnation (Matthew 25:31; I Thessalonians 4:16,17).
6. **We believe** in the spiritual unity of believers in our Lord Jesus Christ (Romans 8:9; I Corinthians 12:12-13; Galatians 3:26-28; Ephesians 4:3-6).
7. **We believe** in the present ministry of the Holy Spirit, by whose indwelling the Christian is enabled to live a godly life (Romans 8:13-14; 1 Corinthians 3:16; 1 Corinthians 6:19-20; Ephesians 4:30; Ephesians 5:18)

PROGRAM OVERVIEW

At Cross Creek, parents are the primary teachers. As such, they are considered to be classroom instructors with their home functioning as a satellite campus of Cross Creek Christian School, Inc. for the purpose of schooling their own child. Tennessee state law requires instruction to occur four hours each day, five days per week, for 180 days per school year.

Cross Creek provides three program options. These include the following programs:

The University-Style

Cross Creek offers educational opportunities in much the same way as a college or university. This system gives parents the freedom to decide which classes will enrich their child's educational program. Students can enroll in just one or two classes, or a full course of study. They attend class twice per week and receive detailed lesson plans to follow during the remaining three days of home study.

Classes are offered for 7th – 12th grades on Monday thru Thursday depending on the classes & PreK – 6th on Mondays thru Thursday. These classes are designed to be an opportunity for students to work with qualified instructors with a challenging curriculum. The classes may not meet the needs of every child. Please be aware that we are in partnership with parents to facilitate their student(s) progress in academics. If a student's needs are not being met within the framework of the classroom setting and chosen curriculum, parents are encouraged to seek other or additional resources. Please see this year's class schedule to discover what is being offered. Most classes are limited to twelve students.

Total Home Education (T.H.E.) Program

We believe parents have the right to home-educate their child(ren) in the way they feel is best. You may choose the curriculum that best fits your academic plan and teaching style. Home educated students that successfully complete Cross Creek's graduation requirements will receive a Cross Creek High School Diploma and may participate in its graduation ceremonies. We provide official transcripts as well as academic and curriculum consultation. We are here as a support for you!

The T.H.E. Program offers the most flexibility by allowing the parent to choose the subjects and curricula tailored to their family's needs. Parents shall provide an academic plan at the beginning of each school year, outlining the course work that their student will be attempting.

The Board of Directors may require that the parent/guardian call the school office monthly to schedule an appointment with administration. These appointments must be kept and an appropriate amount of schoolwork must be shown. A monthly consultation fee of \$25 will be charged if these conditions are imposed.

Grade Reporting for All Programs

Through our partnership with Home School Reporting Online, all registered Cross Creek families report grades and attendance online, any time. Other available features include a lesson planning tool and a student portfolio that lends itself to tracking high school volunteer hours, and achievements for college and scholarship applications. At the end of the fall and spring semesters, parents are required to complete attendance and grade information for their student/s through the school's online reporting system. **Parents may choose a traditional “paper” reporting method for an additional \$5.00 processing fee.**

ADMISSION POLICIES

Application Process

Students that were not enrolled at Cross Creek in the previous school year must complete a formal application before they can be accepted into Cross Creek's program. A non-refundable application fee must be paid at the time you submit your application (this does not guarantee admission). All families must complete an interview with the Administrator /Principal and/or the Academic Coordinator. After the completion of the interview, the application is then presented to the President/CEO for final approval.

If your student(s) is not taking a full load of classes from Cross Creek, you must submit with your application an academic plan on the form provided. This plan must list all subjects that you are planning to teach (specific course titles for high school students), with the name of any textbook publishers or titles that you will be using. We allow you full academic freedom to choose the curricula.

Providing false information on the application will result in an immediate dismissal from Cross Creek Christian School. Further, completion of an application means that you are agreeing to cooperate and comply with the policy and procedures of Cross Creek Christian School. Upon acceptance, Cross Creek Christian School will notify your child's previous school of his/her acceptance and request his/her academic records. After receiving official school records, the administration will complete a final review for policy compliance.

Acceptance Policy

Acceptance into our program is a privilege, not a right. Students making application that have had past suspensions or expulsions, who are currently on or threatened with probation for truancy, or who have been convicted of a misdemeanor offense may not be accepted as a student at Cross Creek Christian School. Students with legitimate reasons for past issues, such as truancy due to extended illnesses, may be accepted on a probationary period. The conditions of probation are established on a case-by-case basis and are strictly enforced.

Cross Creek's acceptance of students is contingent upon social and academic behavior that is compatible with the school's standards. Cross Creek reserves the right to suspend or dismiss any student whose personal behavior, or that of his/her family members, is deemed detrimental to the school. **Any new student(s) accepted will be on academic and social probation for the first semester.** Academically the student must maintain a 70 or higher in all academic areas. Socially, their behavior must be in compliance with the guidelines listed within this policy manual.

Upon acceptance, you are requested to provide Cross Creek the following documents: Official State Immunization Form or letter explaining religious objection; Official School Entry Medical Form (Physical); Copy of Birth Certificate; Authorization to Consent for Medical Treatment; and Student Medical/Emergency Information.

FINANCIAL POLICIES FOR UNIVERSITY-STYLE CLASSES

Tuition and Fees

A formal enrollment/tuition contract must be completed and signed before the first day of class can be attended. Upon signing of the contract, the parents or legal guardian(s) are responsible for the full payment of the tuition for each course for the entire academic year.

This contract can be cancelled if a family provides documentation that they will be moving more than 45 miles away from the school or if Cross Creek Board of Directors agrees to dissolve the contract.

All tuition charges and fees are due at the time of registration, unless a Deferred Payment Plan has been accepted by the Administrator or the Board of Directors. Application, registration, lab, music, books, testing, technology, graduation and any other materials fees are payable at the time of registration and are non-refundable.

Payment in Full

Tuition for the complete academic year paid in full by August 1 will receive a 4% discount off of the total tuition. No discounts will apply for late registrations.

Deferred Payment Plans

Cross Creek's Board of Directors have established the following deferred payment plans:

- 10-Month Plan: tuition is divided evenly over a ten-month period beginning August 1st and ending May 1st.

Deferred Payment Plan payments are due on the first of each month or period. Tuition will be prorated for students that register after September 1st. Account statements will be mailed on a quarterly or as needed basis.

Late Fees/Returned Check Fee

A late fee of \$25 is assessed for outstanding balances received after the 15th of each month. Returned payments due to closed accounts or insufficient funds will be assessed a \$35 fee.

Overdue Accounts

Accounts that are overdue will be reviewed by the Board of Directors, which reserves the right to dismiss the student(s) from the school when the family account is overdue by 30-days or more and satisfactory arrangements for payment have not been made.

Account balances that must be turned over for collection with an outside agency will have collection cost, including court cost and legal fees, added to the account.

All financial obligations must be current prior to registration for the following year. Cross Creek will not release student(s) grades, transcripts, records, or diplomas until your account is current.

Drop/Add Policy (Tuition Refunds/Credits)

All requests for dropping and adding classes must be made in writing. A drop/add form must be completed in order to drop or add a class after initial enrollment. Classes dropped can be replaced with a class of equal or greater value with no penalty.

Classes being dropped will be credited at the following rates:

- 50% of the remaining tuition charges will be credited for classes dropped before the end of the first quarter.
- 30% of the remaining tuition charges will be credited for classes dropped before the end of the second quarter.
- No credits will be given for tuition of courses dropped after the second quarter.

Financial Assistance

Request for need-based scholarship assistance must be in writing using the scholarship request form. Each request will be reviewed on a case-by-case basis by the administrator. When the family need is greater than 35% the Board of Directors must review the request and approve additional scholarship aid. Students must remain in good academic and social standing to keep the scholarship aid.

BEHAVIORIAL EXPECTATIONS

Standards for Behavior

Cross Creek Christian School holds a high standard for behavior. The following is a list of our expectations for all of our students:

- Follow all policies of the school, including those found in this policy manual.
- Show honor to God in speech, dress and conduct.
- Make studies a priority and continue to do your personal best at all times.
- Accept your place of leadership to younger students and model appropriate behavior to them.
- Strive to follow Colossians 3:23 by doing everything as unto the Lord, including showing a positive and constructive attitude.
- Guard against cheating, lying, and other dishonoring behaviors.
- Develop your gifts and talents in order to build up others around you.
- Show respect to classmates by demonstrating kindness and refraining from teasing, gossip, and hurtful actions.
- Seek opportunities to daily serve others around you by putting others before yourself.
- Follow directions the first time they are given.
- Show respect by being courteous in the hallways and by careful use of the facilities and grounds.

Unacceptable Behavior

Direct disobedience or disrespect to faculty or staff is not acceptable; nor is disrespect to other students. The following are examples of unacceptable behavior:

- Lying/Cheating/Forgery/Stealing
- Profane or vulgar actions or language
- Inappropriate use of school property, including building, furnishings, books, etc.
- Physical violence against staff or other students
- Bringing a weapon to school
- Uncontrollable behavior
- Bringing illegal drugs and/or drug paraphernalia to school
- Teasing and/or bullying
- Conversations among students about sex
- Public displays of romantic affection

Violations will result in disciplinary action, which could lead to dismissal. The administration will work closely with faculty and staff to ensure that all discipline is administered in a just, discreet, and constructive manner. The administration will use its discretion on a case-by-case basis to determine the severity of the offense, and the parent will be notified of any disciplinary actions taken. Repeated offenses will result in dismissal from the school. Cross Creek does not administer corporal punishment.

Toys, Cell Phones, and other Electronic Devices

We ask that students refrain from bringing any type of toys or recreational magazines to school. These things do not lend themselves to a productive academic setting and can cause unnecessary distractions. Because parents are very specific and individual in what they do and do not allow their student to watch (videos), play (video games), and listen to (music), we ask that students leave their electronic devices at home.

We understand that many of the students carry cell phones for emergencies, and to keep in close contact with parents. Cell phones must be put in a pocket, purse, or backpack while the student is on campus. Lower level students are not to use cell phones during school hours without permission from teachers or staff. Upper level students will not be permitted to use their cell phones in the classroom.

Violations of these rules will result in the cell phone being given to the principal. The cell phone will remain with the principal until the end of the school day, when the parent will have to retrieve it.

Dress Code

Students attending Cross Creek University-Style classes, or other school-sponsored functions (including field trips), are required to dress neatly and modestly. Specifically, polo shirts with a collar and khaki style pants/uniform skirts. See attached document for more details. No spaghetti straps for the ladies, no bare midriffs, no baggy clothing that would expose undergarments and no short skirts or shorts. Skirts and shorts should come to three inches above the knee.

Violence Policy

Cross Creek has a “zero tolerance” policy involving threats or perceived threats of violence by students or parents. The school’s first responsibility is the protection of its students. If a student brings a weapon to school, or to a school function, or has a weapon on his/her person, the school will immediately expel the student. Parents are advised that the school will contact local police or appropriate authorities, and will note in the student’s permanent record that he/she was expelled for possession of a weapon on school premises or at a school function. Possession includes, but is not necessarily limited to, having a weapon in clothing, book bag, purse or vehicle.

If Cross Creek determines that a threat of violence is credible and specific (directed toward particular students, faculty or staff), the administration will report the threat to the student and/or staff member threatened. The school will immediately report the threat to the parents of the student and may also report the threat to appropriate authorities. Students making such threats will be expelled. For purposes of this policy, credible means a reasonable belief or suspicion, determined at the sole discretion of school administration, that the threat was or might be genuine, or that the student was or might be capable of carrying out the threat. The student’s permanent record will reflect the suspension for making a threat of violence.

In those circumstances in which the school determines that the threat is likely not credible, the school will suspend the student pending a parent meeting. These include all cases in which the student was “just joking”. If circumstances warrant, the school may conduct further

investigation. The school may require students in this circumstance to obtain counseling, at family expense, from a Christian counselor or other professional agreeable to the school. That student will not be permitted to continue enrollment in the school until the counselor advises the school that the student, in the counselor's opinion, does not present a threat of danger.

Sexual Conduct and Identity Policy Statement

In spite of popular culture, Cross Creek Christian School strives to uphold a Christian Worldview that is based on Biblical beliefs and criteria for Biblical morals and values as the standard for conduct for members of our board, administration, teachers, staff, parents and students. Romans 12:2 says, "Do not conform to the pattern of this world, but be transformed by the renewing of your mind. Then you will be able to test and approve what God's will is, his good, pleasing and perfect will."

The biblical and philosophical goal of Cross Creek Christian School is to develop students into mature, Christ-like individuals who will be able to exhibit a Christ-like life; of necessity, this involves the school's understanding and belief of what qualities or characteristics exemplify a Christ-like life. Even though parents and/or students may personally believe differently, while enrolled at Cross Creek Christian School, all students are expected to exhibit the qualities of a Christ-like life espoused and taught by the school and to refrain from certain activities or behavior.

Thus, Cross Creek Christian School retains the right to refuse enrollment to, or to discipline, including suspension or dismissal, any student who:

1. Engages in premarital sexual acts, promotes their sexuality through social media (including e-mails, texts, and websites), or engages other students in conversation regarding sexual matters. (see "Unacceptable Behavior" under "Behavioral Expectations") (Proverbs 5, Matthew 5:27)
2. Professes to be homosexual/bisexual, is practicing homosexual/bisexual acts, or is publicly supporting the homosexual, bisexual, or transgender lifestyle and/or agendas (Leviticus 20:13, Romans 1:26-32; 1 Corinthians 6:7-11)
3. Professes to be transgender or actively engages in activities in an attempt to change their sexual identity away from God's original design. (Psalm 139:13-14, Genesis 2:7,22-23; Mark 10:6-9)

Cross Creek Christian School is a private religious institution that embraces very specific tenets of Christianity; it is not a venue for the free discussion of ideology. By publishing a statement of beliefs and a code of conduct, Cross Creek is making its Biblical beliefs and ideology available for parents and students to review before enrolling/re-enrolling in the school. By choosing to enroll/re-enroll, families are making a commitment to acknowledge the school's Biblical beliefs as the basis and authority of that ideology, and follow the codes of conduct inherent to it.

Video Surveillance

For the safety of our students, parents, faculty, staff, and administration, Cross Creek's facility is under 24 hour recorded video surveillance. Video from the various cameras on campus may be stored for future reference and may be reviewed to determine policy or criminal violations.

ACADEMIC POLICIES

Parent Commitment

Cross Creek Christian School is a parent-directed home education program that recognizes parents as their student's primary teacher. Parents are required to instruct their children at home. Families are encouraged to enhance and individualize the home education program as needed. Cross Creek Christian School's administration and teachers are available to give guidance in regards to individualizing a child's educational plan.

Attendance

Tennessee state law requires that each student spend four hours a day, five days a week for a total of 176 days pursuing his/her education.

Curriculum

The curriculum at Cross Creek has been chosen through a cooperative effort involving parents, instructors, administrators, and members of the board. In an effort to continue to provide students with the best education possible, it is constantly under review.

Those families choosing the University-Style program will pay for curriculum and any associated class fees (such as lab specimens, copy costs, etc) at the time of registration. Families choosing the T.H.E. program will need to provide an academic plan to the administration, and, upon approval, are responsible for the purchase of their chosen curriculum.

Grading/Progress Reports

Each student enrolled in University-Style classes at Cross Creek will receive an identification code. This code enables a parent or guardian to register the student on our grading website (www.ccgrade.com), a free, secure online grade book. This grade book allows parents to view their student's grades as soon as they are posted. These grades will represent tests/evaluations, assessments, class assignments, and projects assigned by the classroom curriculum and lesson plans, and the instructor's expectations. As such, they will not reflect *parent-assigned* course work, extra credit, make-up work, or test grades.

Grading Scale

The following grade scale will be used to report academic progress:

A+= 96-100	A=90-96	B= 80-89
C=70-79	D= 60-69	F= 59 and Below

Academic Expectations/Probation

All students enrolled in University-Style classes at Cross Creek Christian School are expected to maintain an overall *CCgrade* (instructor-appointed) grade point average (GPA) of 1.5 or greater for each nine-weeks grading period. Failure to maintain this GPA level will result in a student being placed on academic probation. If the GPA does not return to an acceptable level by the end of the next grading period the student may lose scholarship assistance and/or be dismissed from the Cross Creek University-Style program.

A student whose final instructor-appointed grade in a University Model class is below a 70.0 will require approval from the administration before he/she is enrolled in a higher level University-Style course in the academic sequence. (For example: an instructor-appointed grade of 69.5 in Cross Creek Algebra 1 would mean that enrollment in Cross Creek Algebra 2 would require administrative approval.

Class Days

The following is the class schedule for University-Style students:

K4 – 6th grade: Monday thru Thursday
7th – 12th grade: Mondays thru Thursday depending on each child's schedule

The instructors of the University-Style classes endeavor to teach new concepts on class days; therefore, parents are encouraged to make sure their student attends if at all possible.

School Activities

Cross Creek offers extracurricular activities that are open to both the University-Style and T.H.E. program students and their families. These include various Friday field trips, and more. We also offer school pictures, yearbooks/annuals, and graduation ceremonies for kindergarten 6th grade and high school seniors.

Annual Achievement Testing

Cross Creek offers standardized testing every year for students in kindergarten through twelfth grades. While these tests are not mandatory, parents are encouraged to enroll their students in testing each year as a way to gauge academic progress. A fee is charged to cover the cost of the administration, testing materials and scoring.

Graduation Requirements

A graduate of Cross Creek must satisfy the following requirements:

- 22.5 total High School Credits
- A minimum score of 860 on the SAT (Math and Verbal), or a minimum score of 16 on the ACT; or 12th grade equivalency on the Classical Learning Test (CLT) or TABE Assessment; or successful completion of the HiSet.
- Students with an Individual Educational Learning Plan (IEP) due to a documented learning disability may request a reduced or exemption from the minimum score requirement. This is a case by case bases pending the IEP.
